Furthermore, the mobile device lending program is designed to help students better integrate technology in their studies and reading habits.

### **Unacceptable Uses of Borrowed Mobile Devices**

The following uses of borrowed mobile devices provided by the Library Learning Commons are unacceptable:

- Selling or purchasing any illegal substances
- Accessing, transmitting, or downloading pornography, obscene depictions, harmful materials or materials that encourage other to violate the law.
- Transmitting or downloading copyrighted materials
- Uses that involve obtaining and or using an anonymous email site
- Uses that cause harm to others or damage to their property or their character
- Accessing another users email
- Damaging computer equipment, files, data or network
- Using profane, abusive, and impolite language
- Disguising one's identity, impersonating others, or sending anonymous e-mail messages.
- Threatening, harassing, or making defamatory or false statements about others
- Accessing, transmitting or downloading offensive, harassing, or disparaging materials
- Accessing, transmitting or downloading computer viruses or other harmful files or programs, or in any way degrading or disrupting any computer system
- Using borrowed mobile device to pursue hacking, internal or external to the district, or attempting to access information that is protected by privacy laws
- Uses that jeopardizes access or lead to unauthorized access into accounts or other computer networks are unacceptable
- Commercial uses of the borrowed device is unacceptable
